MEMORANDUM FOR All Members of the United States Army Garrison (USAG)

SUBJECT: USAG Wiesbaden Command Policy Letter #22, Environmental
Management System (EMS)

1. Reference. Army in Europe Regulation (AER) 200-1, Army in Europe Environmental Quality Program, 8 May 2012.
2. Purpose. The purpose of this policy statement is to express the USAG Wiesbaden's commitment to environmental protection and enhancement, pollution prevention (P2), and continuous improvement.
3. Applicability. This policy applies to all Soldiers, civilians, and contract personnel in the USAG Wiesbaden community.
4. Policy:
 - a. Ensure all garrison activities are in compliance with applicable environmental policies, laws, regulations, and any other requirements to which the garrison subscribes.
 - b. Employ practices and procedures to prevent activities and/or conditions that pose a potential threat to human health, safety, and the environment.
 - c. Constantly monitor the garrison's activities to ensure that they do not adversely affect the environment. To this end, we will annually identify our significant environmental aspects and ensure that these are considered when establishing objectives, targets and our environmental programs.
 - d. Commit to our continual improvement and to providing for future generations with the full integration of sustainability into our business practices thereby minimizing resource use and preventing pollution to the maximum extent practicable.
 - e. Strive to fully integrate the EMS into our mission procedures and work which ensure an increased environmental awareness and regulatory compliance as part of the way we perform our daily garrison activities.
 - f. Cooperate with all host nation agencies to advance our common environmental objectives.
